

Hello,

The reason I would not reply via *Digital Journal* is because I like writing for the website, not for the money, it's peanuts, but I am of an age where that does not matter. In particular I would not want to offend David Silverberg, who has shown the sort of integrity lacking in many journalists.

In 1996-7 I spent six months on remand on a charge of threatening to kill some obnoxious little government snoop; a charge that was based on an off-the-cuff remark. These filth came within a whisker of destroying me. Then, after I was acquitted they stitched me up not once, but twice, and at one point even used an *agent provocateur* to incite me to commit a murder.

In January 1999, the person concerned, obviously an undercover police officer, handed me a gun with which I could exact revenge on one of my persecutors. I had documentary evidence regarding this person, which I gave to a detective at Islington Police Station in front of four, perhaps five, other detectives.

In 2006, at a civil court hearing, he denied he had ever seen it.

I have also written extensively about both Al-Qaeda – which does not exist as such. I have never believed Bin Laden personally ordered 9/11, although he may well have

inspired it. I have also gone on record in defence of both Moslems and Islam at a time when it would have been in my own interests not to do so; one of the reasons I severed all contact with Nick Griffin was because of his attacks on Islam.

I am the last person on Earth who would be employed as or offer his services as a government or globalist shill, but I have made a name out of exposing liars, and will continue to do so.

The 9/11 Truth Movement is made up of people who are deceiving the world, and in many cases have deceived themselves and are being deceived.

The most obnoxious thing I find about this movement is that in analysing it I find myself agreeing with the likes of Abraham Foxman, the most evil Jew in America, a man who has openly condoned both the Gaza Massacre and the Flotilla Massacre.

Richard Dawkins once compared 9/11 Truthers with the people he calls Holocaust Deniers. The big difference between Revisionists and Truthers is that true Revisionists are willing to accept documented and irrefutable facts.

What happened in the camps is something entirely different. Essentially, after the War, the Americans took photographs of the Dachau delousing chambers and shower, then presented them to the world as “proof” that the Nazis had gassed Jews. The British did the same with photographs of emaciated typhus victims at Belsen. Even though there was never any serious claim that Jews were gassed at Belsen, the public perception remains so to this day.

With Auschwitz, a similar trick was pulled; a mortuary was presented as a gas chamber. With the Aktion Reinhard camps, even that was not necessary. Mass gassings are in any case physically impossible. Check out the original documents of the Final Solution posted on my site, in particular the testimonies of Litwinska and Bialek, and you will see the sort of nonsense that was accepted by the military courts.

With 9/11 though we actually see the planes crashing into the buildings, including the Pentagon, yet the braindeads deny this. All the witnesses are either liars or shills, and the conspiracy encompasses everyone from the Mayor of New York to the FBI, the CIA, the police, the eyewitness in the street, and Uncle Tom Cobbley and all. And of course, anyone who like myself has the temerity to stand up in public and as with the Holocaust say the Emperor of 9/11 Truth has nothing on.
