## The Press We Don't Deserve

On March 16, 1994, a black Guardian journalist named Gary Younge published an interview with Ray Hill, long time mischief-maker, thug, liar and agent provocateur. The interview/article was called Fighting talk, and allegedly covered Hill's career in the far right and as a Searchlight mole. Hill was plausible, but so was Dennis Nilsen, plausible enough to lure more than a dozen young men back to his flat and murder them, mutilate them and defile their bodies. Younge was obviously impressed with Hill, unless his article is every bit as sincere as his interviewee. But he will be much less impressed when he reads this and learns the truth about Hill's anti-black hatemongering. Hill and plausibility go hand in glove, but Hill and truth parted long ago. The current writer wrote the letter (Appendix B) to the editor of the Guardian; I also sent some documentation to Mr Younge. I received an acknowledgment from editor Peter Preston; when I phoned Mr Younge I was informed that he was in South Africa.

Subsequently I contacted the Press Complaints Commission and forwarded them the letter I had sent to Peter Preston. (1) My complaint was rejected on April 28 because the commission took the view that "a newspaper is entitled to report the statements and views of the subject of an interview". Incredibly, Hill's puppet master Gable was called for a quote by two <u>Guardian</u> jour nalists on the eve of the local council elections. (2) Gable, like the damned liar he is, claimed that the vicious assault on BNP press officer Mike Newlands was the work of the so-called Nazi hit squad Combat 18. "They feel that the BNP is becoming too soft and respectable," he said. The idea of the BNP being respectable is every bit as ludicrous as this mischief-maker and enemy of democracy being, in the words of former M.I.5. operative Gary Murray, "a reputable veteran journalist."

Incredibly, that is what Gable is considered in most quarters.

Since 1975 he and his magazine have "exposed" the following:

Column 88, a mysterious "Nazi underground" group which was said by one hysterical "anti-fascist" publication to have an underground army of three hundred men and women who could strike at random and bring murder and mayhem to anti-fascists and their families. (3)

A gun-running conspiracy in Leicester.

The mythical plot to bomb the Notting Hill carnival.

A massive infiltration of takeover of the Young Conservatives by far right extremists.

A plot to kidnap and murder Gable himself.

A plot by a Czech spy to corrupt a junior civil servant.

A worldwide conspiracy to desecrate Jewish cemeteries. (4)

Combat 18, the alleged Nazi hit squad which - Gable claims - is now targeting the BNP as well as the far left.

Gable's magazine claims to have a worldwide reputation for honesty and integrity. It does, but this reputation is totally undeserved. The above alleged criminal conspiracies resulted in three court cases and one conviction. Two of these cases were libel actions brought by MPs. They were both successful and resulted, in the first case, in a massive payout by the BBC, and in the second, in the magazine <u>Private Eye</u> shelling out substantial damages for repeating the absurd allegations of the Gable murder plot which obviously originated with <u>Searchlight</u>. (5) The conviction was of an acknowledged <u>Searchlight</u> mole - read <u>agent provocateur</u> - for conspiracy to assault the staff of an Indian restaurant. (6)

This is not much of a track record. Actually, <u>Searchlight</u> has been responsible for bringing one thug to justice in its 19 years of existence. Tony Wells aka Lecomber, a senior member of the British National Party, was gaoled after attacking a Jewish schoolteacher. The victim, who may have been a subscriber, picked him out from a <u>Searchlight</u> "mugshot". The teacher would probably have identified him from a police photo too, but credit where credit is due.

In his lie-ridden autobiography The Other Face Of Terror, Ray Hill claims to have witnessed a vicious attack on an Asian man in Leicester, a claim which appears to have some substance. (7) The two men who perpetrated this attack were arrested for it, but without Hill's evidence they walked free. However, it may be that Hill incited the attack in the first place. Keith Thompson, a well known figure on the far right, had this to say about Hill: "I went to speak at one of his meetings in Leicester. As soon as we were in the car he started talking about how he'd smashed Paki's off their bicycles...how he'd done it, how he loved doing it, and how we all ought to do it. This was about the mid-eighties. I've never done anything like that, never heard of that sort of thing before. I thought 'What's this guy's bloody game?'" (8) This has in fact been the most consistent thing about Search-<u>light</u> over the years, the criminal activity of its "moles" who all play up to the baby-eater, sex-shop Nazism of publisher Gable's warped imagination. Gable regularly boasts that he runs "moles" in all Britain's far right groups. The reality of course is that the only crimes these "moles" uncover are those they themselves incite. Which brings us back to Mike Newlands.

The vicious assault on Newlands followed the publication of his photograph in <u>Searchlight</u>. (9) By an extraordinary coincidence, a hammer attack on the current writer followed hard on the heels of allegations made against him in the November 1993 issue of the magazine. (10) Another person who has been mentioned frequently in <u>Searchlight</u> has also been the victim of harassment, Green Party member Larry O'Hara. Derek Beackon, the former BNP councillor has also been attacked by unidentified thugs. (11) The <u>modus</u>

operandi of all these attacks is not of the non-existent Combat 18 (12) but of Red Action, a group of pro-IRA thugs who were expelled from the Socialist Workers' Party in 1982. They worked hand in glove with Gable during the Kensington Library invasion in 1991 which led to Gable facing criminal charges. He was acquitted, much to the disgust of the police. (13)

The April 1993 issue of <u>Searchlight</u> contained an alleged massive exposé of Combat 18. The same month a <u>World in Action TV</u> "documentary" (screened the 19th), carried a similar <u>exposé</u>. The key men behind this "conspiracy" were identified as Paul David (Charlie) Sargent and Eddie Whicker. Whicker is a South London dustman, former member of the National Front Directorate, NF Parliamentary Candidate and Ulster "Loyalist". Although he mixes in ugly company and is probably not the sort of person you would invite to tea, he is, politics aside, an ordinary working man. Sargent is a rather more odious character.

According to <u>Searchlight</u>, April 1993, page 8, Sargent has two convictions for drug dealing - in Sweden and Britain - and for political violence. A source close to Sargent (in an undated letter received May 18th, 1994) defended him on the grounds that his drug offence (singular) was "some 15 years ago" and his only other brushes with the law have been for "violent things", which means that "he isn't a crook" !! Leaving aside the political violence, Sargent's commitment to circumventing Britain's Draconian anti-drug laws and obvious endorsement of the free market would do him proud in Libertarian circles. But this is not the stuff of good National Socialists.

In the "documentary", Sargent was hassled in the street by the film crew, and was obviously none too polite. Off camera he was given a going over by a bunch of "anti-fascist" thugs. (14) Whatever their antecedents - and Sargent's are appalling - the idea that these two men are major players in a criminal conspiracy of national dimensions is more than a little absurd. Notwithstanding that, Gable and his fellow liars have managed to convince a substantial tranche of the media that this is actually the case.

This is bad enough, but the March 1994 editorial of Gable's lieridden magazine claimed that the chief constables of no less than five police forces have been taking Combat 18's alleged "declarations of war" seriously. The same editorial attacked the Home Secretary for his "pathetic performance", ie not dancing to Searchlight's tune. The reality is that the Home Secretary, the Home Office, and most police forces, have far better intelligence than Gable assumes. All the same, it is extraordinary that a man of his known subversive background - a hatemonger and a many times proven liar - should be called upon to give "evidence" to a Home Affairs Committee investigating racial attacks. It is even more extraordinary when one considers that the chairman of this committee, Sir Ivan Lawrence QC MP, represented Gable when he was charged with - and later convicted of - burglary artifice at the home of the historian David Irving, (15) and is therefore au fait to some extent with Gable's real agenda. (16)

He and his fellow hatemongers and liars have been leading the media, the "anti-fascist" movement, Jewish organisations and individuals, and academics, up the garden path for almost as long. The <u>Searchlight</u> organisation's real agenda, and Gable's, is the destruction of Western man's democratic institutions, and to that end he, and they, have not stooped to ferment hatred, racial tension, bigotry, and lately, outright terror, under the ingenious guise of combating these very evils.

Dear Sir or Madam,

I am writing to complain about the enclosed article. I wrote a lengthy letter to the editor of the Guardian and received a two line reply. I enclose both. I have also annotated the letter see the footnotes; this forms the basis of my complaint. When I phoned the <u>Guardian</u> on Monday I was told that Gary Younge was in South Africa and would be there for five weeks. I would like something done about this article much sooner than that. I must stress that although you deal primarily with complaints against newspapers, my complaint is not against either the editor of the <u>Guardian</u> or the journalist who wrote the article. I do not dispute for one moment that this article was published in good faith. My complaint is against Ray Hill, who, together with his puppet master Gerry Gable, are the world's master liars. The worse thing that can be said of the Guardian is that Mr Younge has been naïve. However, Gable and his gang have been hoodwinking the media and to some extent the authorities for the best part of thirty years, so this is not an insult. I had hoped that Mr Preston would commission an article from me on this organisation, but that was a faint hope. I should also point out that I am currently engaged in litigation with Mr Gable, though not with Mr Hill. I have also filed a complaint

## Appendix B: Letter To The Editor Of The Guardian

Dear Mr Preston,

Last Wednesday you published an in-depth interview with former British National Party member Ray Hill. I find this rather strange as late last year I sent you a documented exposé of this arch-liar and his puppet master Gerry Gable. If the <u>Guardian</u> continues to publish trash like this it will soon lose its reputation. Here is a summary of Hill's lies:

Hill was 22 years old in July 1962 (17) when he was jailed for wounding a police officer, so he couldn't have been 28 in 1964. He didn't join the Anti-Immigration Society in 1964 because it wasn't founded until March 1968. (18) Nor was he living in a squalid flat with his family then because he didn't marry until 1966. (19)

Hill was never a member of the National Socialist Movement; this is a blatant lie. (20) He was a member of the British Movement for a little over a year. He first met Colin Jordan in November 1968. At this meeting Hill assaulted a press photographer - one of your colleagues, take note. The following August he committed a serious assault on a Jewish café owner. Both he and Gable try to play this down; consult the <u>Jewish Chronicle</u> for ten years later - July 13, 1979, page 10 - and you'll see this was a vicious attack.

Hill fled to South Africa to escape a gaol sentence; he was already serving a suspended sentence for the assault on the press man and would certainly have been sent down. In South Africa Hill was employed by wealthy Zionist Jews as an agent provocateur to smear the HNP as anti-Semitic. At an HNP rally in March 1979 he made a virulently anti-Semitic speech which led to the resignation of a top HNP member, (Johannesburg Sunday Express, March 11, 1979, page 10). He was not invited to make a speech but jumped up and seized the microphone. He did not have a change of heart after seeing blacks evicted from their homes; he was one of the organisers of this campaign; (21) the South African National Front was virtually a two man affair: Hill and the late Jack Noble.

Hill is wanted for credit card fraud and embezzlement in South Africa. Here is what he said on two occasions:

"[Larry] O'Hara accuses me of being a convicted fraudster and

arsonist. [In his booklet <u>A Lie Too Far</u>]. I have never been charged with or convicted of either of these offences...", (<u>Searchlight</u>, July 1993, issue 217, page 7).

"In February [1979], a friend had asked me to lend him some money so that he could buy a birthday present for his wife. Not having any cash to hand...I rather foolishly handed him my credit card and told him to get what he wanted...In very little time at all he had run up a bill of more than £3,000, which I was neither willing nor able to pay. The police visited me, and I was charged with credit card fraud..." from pages 65-6 of his fictional autobiography.

### Note the difference?

Hill's claim that he jumped bail in South Africa because his father-in-law died is a blatant lie. There is no mention of this in his lie-ridden book, but the lies grow with every retelling. On Thursday my colleague made a search at St. Catherine's House for a death in that year of Shapcott - Hill's wife's maiden name - and found nothing relevant.

Hill was never third in command of the BNP; he was not contacted by fascists on his return to England; he joined the National Front, and was admitted to the Leicester branch in spite of reservations from the London leadership. He resigned from the Front about a year later but would have been expelled anyway as he had assaulted another member. (22) He does not write a column for Searchlight, this column is actually written by Gable, who may well have had a hand in writing his inflammatory speeches when Hill was stirring up trouble as an agent provocateur, not a mole

Hill's book The Other Face of Terror is a tissue of lies from beginning to end, as is the Notting Hill Carnival bomb plot; it never happened, this was a fantasy dreamed up by Hill, and Gable, who is an even bigger liar than he is. If you want confirmation of this, contact Superintendent Ken Day of the Scotland Yard Special Branch; he'll tell you in his own diplomatic way that this "plot" was a total fabrication. (23) In 1988 Hill tried to frame a Jewish businessman for molesting his sons. George Lewis was acquitted by Lincoln Crown Court. (24)

If you want to know how I know all this it is because I have been researching Hill and <a href="Searchlight">Searchlight</a> for some time. I am looking for a publisher for my book. To date Gable has made no attempt to refute any of my allegations - for the obvious reason that he can't. In the November and February issues of his magazine he smeared me as an anti-Semite and fascist - a charge he will soon have a chance to prove to both the NUJ and a High Court jury. I should add that in this connection the Wiener Library are aware of Gable's allegations and the smears of his friends at the <a href="Jewish Chronicle">Jewish Chronicle</a>, and I am still welcome there as a researcher. I was also the victim of a mysterious hammer attack, and a burglary.

I have just published a pamphlet on Gable which proves that he

lied to the Jewish Chronicle out of his own mouth and using his own words. It's £2.99 post free, but if you commission me to write a minutely referenced article on Hill and/or Gable at NUJ

rate I'll send you a free copy.

Finally, I would appeal to your sense of public duty: Gable is currently giving "evidence" to a Home Affairs Committee; people like him are not fit to give evidence to any committee, least of all the highest in the land. These liars and hatemongers must be exposed and purged from our media and institutions like the cancer they are.

## Right-wing man sentenced

From a Correspondent Raymond Hill, aged 39, the former secretary of the right-wing British Movement branch in Leicester, appeared at Leicester Crown County last week on charges of damage to property and occasioning actual bodily harm to Mr Peter Josephs ten

Hill pleaded "not guilty" but admitted smaller charges of "common assault".

Prosecuting, Mr M. Stokes stated that on August 21, 1969, Mr Josephs was punched several times in the face, by Hill, who was known to have "strong political views". It was also alleged that while committing the offences, in Mr Josephs' coffee-bar, Hill shouted, "Bastard Jew".

when leaving the dock Hill raised his arm in salute to four young men in the public gallery.

In his fictionalised autobiography The Other Face Of Terror, Hill claims that his 1979 conviction for assault ten years earlier on café owner Peter Josephs was just a bit of bother and that his manipulator Gable "blew it up into a vicious attack on a Jewish man". The Jewish Chronicle didn't see it that way though, neither did the Leicester Mercury. The court report from the former is reproduced above right. In 1988, Hill demonstrated his commitment to fighting anti-Semitism in an even more positive manner when he tried to fit up Jewish businessman George Lewis. Hill had known Lewis in South Africa, and, by a remarkable coincidence, turned up in Lincolnshire several years later and tried to muscle in on his business. When Lewis objected, Hill accused him of molesting his sons. The court report from the local press (left) was picked up by the British National Party's theoretical journal, Spearhead. Editor John Tyndall concluded that Hill, who once professed to be a dedicated National Socialist, never really believed in anything. Certainly Hill's wealthy Zionist backers must have had second thoughts when they heard about this. Perhaps Gable will eventually too. Who knows, Gerry, it might be you he stabs in the back next.
