## LEGALISE 'PORNOGRAPHY' NOW

FREEDOM OF EXPRESSION  
AND STATE SEXUAL CENSORSHIP IN THE U.K.

In nearly all other European Community Member States and most other 'Free World' countries, people are free to buy and sell sexually-explicit material (often referred to as "pornography") without being subject to State censorship laws. (In France, Germany, Italy, Holland, Spain, Portugal, Denmark, Greece, U.S.A., Australia, Brazil, Czechoslovakia, Poland, Rumania, Hungary, etc.) IN THE U.K., HOWEVER, WE DO NOT HAVE THIS FREEDOM, and are still subject to the most repressive State censorship prohibitions.

If you are angered by this intolerable, unique U.K. State interference in personal sexual morality and object to being dictated to by the State about what you are allowed to see, read and hear:—

(1) WRITE NOW TO YOUR LOCAL M.P. AND TO THE HOME SECRETARY (Address: Home Office, 50 Queen Anne's Gate, London SW1H 9AT) TO PROTEST AND DEMAND THE IMMEDIATE REPEAL OF OUR AUTHORITARIAN SEXUAL CENSORSHIP LAWS.

and
