**Although he never really made it in the States, Rolf Harris was a massive star in Britain where he has lived since the 1950s, and in his native Australia. He was one of the victims of the *Operation Yewtree* witch-hunt which destroyed the lives of so many of the men who had entertained us over the past half century.**

**One of these men was the former DJ Dave Lee Travis. At the end of his retrial at Southwark Crown Court, he thanked William Merritt. I looked into Merritt then wrote to Rolf, who was then in prison serving an unwarranted five years and nine month sentence.
