Thanks for sending all the cuttings,
and your letter of 20th August with
your 'sexual freedom Bill'. It's
great.

I have responded to Nick Clegg's
on line survey which invited ideas
from the public. It was not very
well designed & doubt that it will
get used. On the other hand, your
Bill is really useful.

Do you have the Bill on a computer
and can you send me a copy on disk
or via email?

I have stopped doing things with the
SFC for several reasons. First, the
people helping have all disappeared
off. Second, the arguments seem to have

more strength when coming from the disability perspective. For example the Outsiders a TLC-Trust.org uk sent a Freedom of Information survey to local authorities asking for their policies on disabled people being allowed to enjoy sexual freedom and pay for sex workers. This was reported in Community Care, made the front page of the Telegraph & two peices in The Daily Mail, etc.

So I thought I could put your Bill up on the SFC website and email it to Nick Clegg too. I would imagine it would be easier to understand if the language were less legal-talk but we would have to sit down together to do that.
