One of the things the Sexual Freedom Coalition has done is to draft a Sexual Freedom Bill, which we'll be presenting to the Home Secretary on Midsummer's Day.

During the drafting of this bill, the question emerged: "WHY are the British so afraid of public sexual liberation, WHY do politicians cling onto repressive laws and WHY do the British public put up with it?"


compartments, in order to "enjoy the best of both or many worlds".
