Dear Mr. Webb,

Further to our phone conversation a few days ago I now enclose, as promised, copies of correspondence to and from H.M. Customs. I also enclose original page from "Video World" regarding the advertiser "Crownville Videos" whose advert motivated me to write to them to see what evidence they could provide to substantiate their printed claim. Although a SAE was enclosed no reply was ever received which confirms that as the law stands it provides an absolute heaven for rackateers, con men and fraudsters for whilst explicit videos are illegal it does not seem to be illegal to advertise them even though they cannot be provided. "Exchange & Mart" and other papers are full of similar adverts.

Your telephone comments as to what appertained prior to the advent of video and the typed addition to your Campaign leaflet on the introduction of the 1984 Video Recordings Act certainly illustrates that the Authorities keep up with what is happening in the world!! Or do they? Not only has the world been introduced to video but it has also been introduced to AIDS and I would have thought that obtaining satisfaction from viewing videos is much more in the interests of public health than if the would be viewer was to instead have frequent "one night stands" or associate with ladies from the oldest profession which itself is licenced and regulated in many countries but of course, not here. Even worse some who are deprived of such material may obtain their satisfaction by committing a serious sexual crime. It is therefore clear that so called obscene material would not only be in the interests of public health in the war against AIDS but also in the interests of public safety as well.

I note that the Williams Committee was in total agreement with free availability and as we already have licenced Sex Sheps (Licenced for what??) controls against sales to young persons and protection of those adults who do not wish to be affronted by such material already exist. But what was the purpose of this Enquiry if no notice is taken of its findings? I can only assume that those in power who commissioned the Enquiry were quite sure that its findings would be completely opposite to what it did in fact return. A not disimilar situation applies where the vast majority of voters favour the return of Capital Punishment in the fight against crime but our "elected" representatives continously fail to heed the wishes of their constituents. SOME DEMOCRACY!!! The way things are going the former Eastern Bloc countries will soon have more freedom than we have.

As far as the Williams Report is concerned it seems, Mr. Webb, that you have, in principle, won the battle but those in power refuse to admit defeat and permit alterations to the law. I would not be at all surprised if the law relating to the burning of Witches was still on the Statute Book, ready for use, if politicians mistakingly thought it would improve their public image.

Incidentally, I am also taking the Government to task on the question of the male retirement age pointing out that it is, and as done so for years, breaking its own Sexual Discrimination legislation as well as being out of step with Europe on this matter too. It seems that the Government wants the Business benefits of Europe but does not want the public to enjoy the same Social advantages and freedom of choice.

I will of course let you know any development from Gatwick but could you let me know if you are at the number I 'phoned a few days ago in the evening as daytime calls from Worthing can be very expensive.

As you will see I have ordered the two publications which I shall look forward to reading and of course you may use either my letter of 6th March and the first page of this communication to achieve the Campaign's objectives. I do not mind the use of my name and hometown but would prefer the rest of the address, postcode and telephone number not to be used but as no action as ever been taken on the 1980 Williams Report I cannot really see how you can make any more progress.
