Mark Taha on Nick Lowles

1992 first met -political conference called by National Association of conservative Graduates (I think). Handed him one of your pamphlets then found out who he was-he told me. Using name Lawrence King. Said things like "I don't talk to Nazis" but did ask if I'd like to meet some time. I was fairly noncommittal.

Second meeting -in Companies House,1994. Day or two before ITV showed tribute to Doris Speed to track it down.

Later claimed that I was "looking for names of Jewish company directors" in his "evidence." During conversation -he mentioned my aunt, said he might call round with a couple of mates, he'd heard Red Action had been round -some idiot had put fireworks through the letterbox a couple of weeks before.

All I can remember -sorry. Saw him at a Freedom association conference in 1995 but he left early.

Aunt died 2019. She'd moved out of her flat years before. Lowles' evidence on Gable's behalf in the libel case.

There'd been fireworks through my letterbox several weeks before. Assumed it was some imbecile.

He said something on the lines that he'd heard Red Action put fireworks through my letterbox. That was in late 1994. All I can remember.

Explanation and comment

The above is a verbatim e-mail received from Mark Taha, April 17, 2024 subsequent to previous correspondence.

The following is from an e-mail received June 10, 2024.

"My last meeting with him would have been a day or two before November 18,1994.

The Thursday attempted assault beginning of June that year -I was out handing out the magazine first thing, out all day, rang you when landlord told me that evening".

A few points, on November 28, 1993, I was the victim of a serious assault by Red Action thugs who had obviously been hired or put up to it by Gerry Gable. I was far from the only person to be attacked so. The following April, Mike Newland was attacked in his North London home. At that time, Newland, not a young man, was the press officer for the British National Party. That assault made national headlines.

Earlier that month, a BNP candidate had lost an eye in a street attack. Like the pond scum he is, Gable claimed this was the result of a feud between "neo-Nazis". Incidentally, I have no recollection of the assault on Michael Davidson; I noticed it first when editing this file on June 9, 2024.

The reference by Lowles to Red Action calling on Mark was incredibly sinister. This was also in 1994. At that time, Mark was living in a dingy bedsit in Stamford Hill. One night after leaving my place, he phoned me and told me his landlord had informed him that two men had called on him with a parcel. At that time, we used to meet Fridays, but that week for some reason that eludes me, we met on Thursday. Had Mark been at home that Thursday, I don't know what these scum would have done to him.

The claim by Lowles that he had met Mark at Companies House and that the latter was researching Jewish company directors is an outright lie. I visited Companies House a few times, including when I was researching the original Searchlight, as will be apparent from this website. Now, everything is done on-line. Lowles did indeed meet Mark at Companies House, but he was doing a regular part-time job. At that time, Mark's stepfather owned a company and would give him the odd job in relation to it. When he retired, he moved to Australia.

As usual, Mr Lowles was being liberal with the untruth, but he still has a long way to go to throw shade on his former boss.
