Rape, False Rape And Simulated Rape In The News

We are forever being told that false rape allegations are extremely rare; the statistics **prove otherwise**, and unlike feminist statistics these are real, not **plucked out of thin air**. The latest **false rape allegation** from Scotland involves a 35 year old woman who went on a date with a much younger man. After having sex with her on the train home he had second thoughts, and did a runner. That was extremely unchivalrous, especially as she appears to have paid for the evening out! What she did next though was criminal, and landed Karen Farmer in the dock.

Although this case dates to August 2012, she has not yet been sentenced, and is now claiming to have been under the influence of alcohol. Although he was cleared of rape, he was convicted of a number of indecent assaults. There were two unusual features of this case; Andrade, who was clearly mentally unbalanced, committed suicide while the jury was out; and Brewer's wife (then his ex-wife) was convicted along with him. Any allegation of a sex offence which involves either a woman suspect or accomplice has to be regarded with suspicion, but Brewer's legal representation was, to put none too fine a point on it, rubbish.

Malcolm Layfield fared better, and [was cleared](#) of rape even though he admitted having consensual sexual relationships with his students, including at least one teenager who was over the age of consent. This trawl of music schools, care homes, etc, is ongoing, indeed the police have indicated they intend to press on with them. This will surely result in further miscarriages of justice. In view of the 5 year sentence [imposed on Ched Evans](#) under entirely different circumstances for a highly dubious rape, one is entitled to ask if this sentence is far too lenient. Arshad Mohammed had not only jumped bail but had sexually propositioned two other teenagers.
