Here's a puzzle for you, how do you insult a feminist? 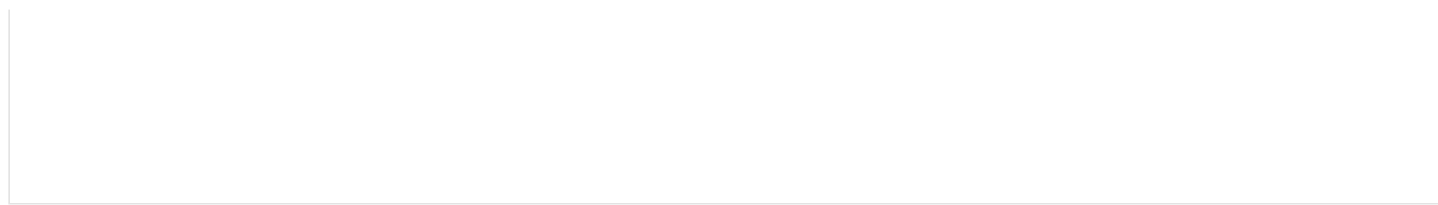

Pao filed a \$16 million lawsuit against her former employer. And lost. From Kleiner Perkins, she moved to Reddit, but didn't last anything like as long. Was she pushed or did she jump? Pao was appealing the Kleiner Perkins verdict but has now decided sensibly not to throw good money after bad. Seriously Ellen, if you could turn back the clock, wouldn't you rather be *oppressed* on \$400K per annum basic than unemployed and with a big cost order to pay? Rest assured, if the lady does find another job, it will be on a considerably more modest salary, and she won't be anything like so litigious in future.

Last October, he posted an excellent **short clip** to YouTube about the lies we all tell every day. It is a pity he can't take a deeper look at this obscene bandwagon, for behind the historical claims of serial rape lie far more plausible tales of greed, fantasising, revenge, mental derangement, and **outright madness**.
