

The Media Lynching Of Bill Cosby

Legal cases are supposed to be tried in courtrooms. A court of law has rules of procedure and evidence. It has strict protocols about what can and cannot be done. Legal cases in courtrooms are tried by lawyers; in the West there is a largely adversarial system. The court of public opinion differs from a court of law in that there are no rules, literally anything goes: hearsay, scurrilous gossip, rumour, lies galore. What sort of lawyer would try a legal case in the court of public opinion? No lawyer who could be trusted to argue one in a courtroom. Sadly, no one appears to have told attorney Gloria Allred.

The hysteria that started back in October last year when the American star Bill Cosby was branded a rapist by a comedian on stage has gathered pace until now over fifty women

have come forward to accuse him publicly of raping or otherwise mistreating them from the 1960s to 2008. For the most part, these women have been edged on by Gloria Allred. The number of accusers is staggering, and for the majority of the public, those who don't understand human psychology, these numbers are impressive. When the partial content of a deposition from Constand v Cosby was released, most doubters were swayed, after all, Cosby had admitted to drugging and raping women. Except **he hadn't**. Gloria Allred tried to effect an air of pleasurable surprise at this point; the pleasure was undoubtedly genuine, but she had unquestionably known the content of this deposition since 2006.

The case against Cosby is still largely one of corroboration by volume. For those not in the know, there are parallels with the witch-hunts that have been going on in the UK for the past two years and more concerning similar alleged historical sex offences. Recently, a police officer here **stated that** if a number of people came forward making broadly similar allegations against an individual, that was proof of his guilt. That police officer is at best an idiot.

Also recently, an experienced QC made **a similar claim** about the former DJ Neil Fox who is shortly to stand trial for sexual offences against teenage and underage girls. The allegations against Mr Fox which date back to 1987 are said to show a "consistent and determined pattern of sexual predatory behaviour".

Unlike that idiot police officer, Sasha Wass is no fool because she prosecuted Rolf Harris knowing full well that at least one of his accusers had never met much less **been abused by him**. In 2013, she successfully defended members of an alleged grooming gang who had been accused of the **systematic rape** of an 11 year old girl. During that trial she had no problem with accusing the alleged victim of both fabricating evidence and suffering from hallucinations. The truth is she is simply a hired gun who cares not one whit about convicting the innocent. Nor do many others, because such is the hysteria over child sexual abuse and rape in English courtrooms that the tears of a demented woman trump physical evidence, reason and logic.

As things stand, Bill Cosby will not find himself in the same position as Rolf Harris and other unfortunate celebrities because the US has statutes of limitations for crimes, including rape, statutes of limitations that Gloria Allred and others are **intent on removing**.

While to the general public, the more women who accuse Cosby, the more damning the case against him sounds, to those who *do* understand psychology and human memory, the case against him sounds more and more ludicrous. At a press conference in August, Miss Allred produced **three new alleged victims**, or survivors as they are now called by feminist airheads. One of these women, Linda Ridgeway Whitedeer, claimed that without any indication of what was about to happen, Cosby lured her to an office on a film set, forced his penis into her mouth, ejaculating over her face, and then told her she was blessed as he wiped away the semen. She was too shocked to do anything, but now, finally, four decades on, she has found the courage to come forward and point the finger at him.

It is more likely that this so-called survivor had read Jim Davidson's book ***No Further Action***. If you haven't heard of Jim Davidson, he is in the same trade as Cosby, although his humour has always been nearer the knuckle. He was one of those caught up in the aforementioned witch-hunt. Davidson was accused of raping and otherwise sexually assaulting a number of women; two of them accused him of oral rape in broadly similar circumstances as those outlined by Linda Ridgeway Whitedeer, although both claimed to have bit his penis, not an unnatural reaction. In fact, when Chima Benson was forced to felate sex murderer Dale Scheanette, she did just that, and although it cost her a vicious

beating, she was responsible more than anyone for him being brought to book and executed.

One of Davidson's accusers said he assaulted her at the stage door of the London Palladium. When he told the police – who hadn't bothered to check – that there was no public access to the stage door at the Palladium, this woman mysteriously changed her witness statement, and when he pointed out that he couldn't have assaulted her at the Slough Pavilion either, the police gave up on her.

The late Jimmy Savile has now been accused of raping dozens of women and indecently assaulting literally hundreds of girls, and a few boys. As with the historical allegations against Cosby, there is no way of determining the truth or otherwise of most of them, but quite a few of these allegations have been shown to be false. A few of the allegations against Cosby are demonstrably false, but the media gives them a free pass.

On October 9, a **TV special** brought together 27 of Cosby's alleged victims, some of whom claimed to have been attacked by him multiple times. There was his kept woman Barbara Bowman; PJ Masten, who had previously **accused another celebrity** of sexual impropriety;

Janice Baker-Kinney who said she blamed herself – totally ignoring the feminist mantra “It’s never your fault”; there was even twice convicted prostitute Chelan Lasha, who also has a conviction for false reporting. These women are as mixed a bag as you could hope to find, but they all had two things in common:

Not one of them filed a police report.

Not one of them attended a hospital.

And we all know why, don’t we? Either of those actions would have left a paper trail. Here is a question for the true believers, if it is inconceivable that every single one of these women and all the others could be lying, how much more inconceivable is it that not one of them would have reported Cosby or undergone some sort of medical examination for drug effects, injuries or sexually transmitted diseases? Yeah, we know, he was such a powerful man, well guess what, so was Bill Clinton. Not only was he twice President of the United States but before that he was Attorney General then twice Governor of Arkansas. He was also handsome, charismatic, and couldn’t keep it in his trousers. Clinton was a prime target for all manner of nutters, including one well-publicised allegation of rape. For some men, this sort of thing comes with the territory, yet none of these *survivors* could file a report against Cosby.

One Cosby accuser who did not take part in this programme was Judith Huth, who kept a photograph of herself with Cosby even after he sexually assaulted her, unlike the woman who claims Rolf Harris indecently assaulted her as a child when she asked for his autograph but didn’t keep it, which is hardly surprising because her meeting with Harris was similar to the sexual assault perpetrated on Huth by Cosby, imaginary.

Now yet another of these pseudo-victims is trying it on, Renita Hill says Cosby assaulted her in 1983; he has denied it, and she is **sueing him for defamation**. Anyone see a pattern here?

The Cosby accusers fall into four broad categories:

Those who knew him, including in the Biblical sense, who have decades later decided their consensual if sordid encounters were non-consensual. These include Barbara Bowman (a woman scorned) and the airhead Therese Serignese.

Those who were acquainted with him who for whatever reason have jumped on this bandwagon.

Publicity whores and chancers – Chloe Goins in the most obvious example.

Demented individuals – Joan Tarshis is the prime example of this, a plausible woman who **communicates telepathically with aliens**.

It is easy to view this as a conspiracy, and it is growing more and more to look like one. Whether or not that is the case, let no one be duped by these women. The ultimate goal of those who are evil rather than demented is to remove statutes of limitations for all sex offences in the US, as Gloria Allred has made clear. If that happens, no man will be safe, celebrity or otherwise, heterosexual or homosexual, and as **the case of Caroyln Keeling** demonstrates, neither will any woman.
